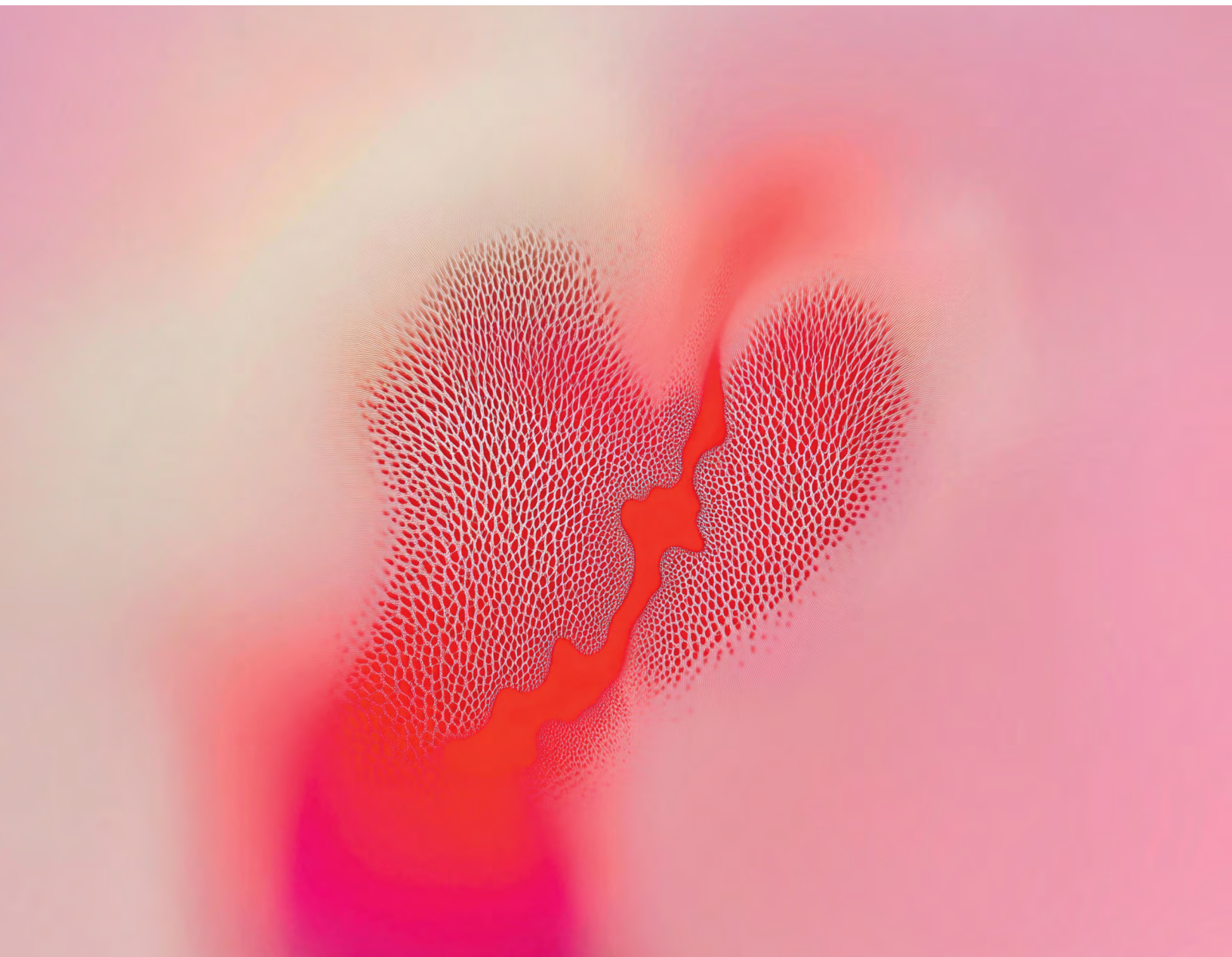

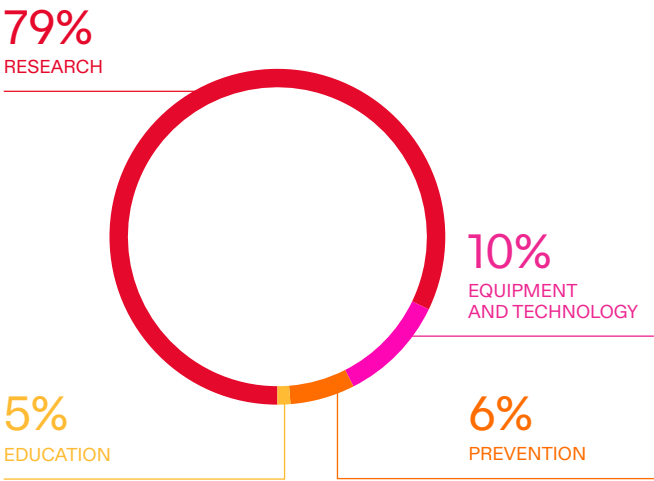
Summary of 2024-2025

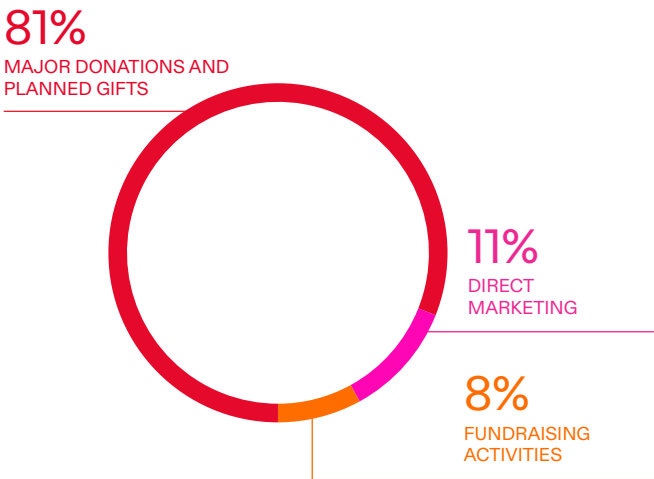
This year, the Foundation collected \$29,324,191. A result that embodies the power of a mobilized community. Thank you for being part of this forward-looking movement.

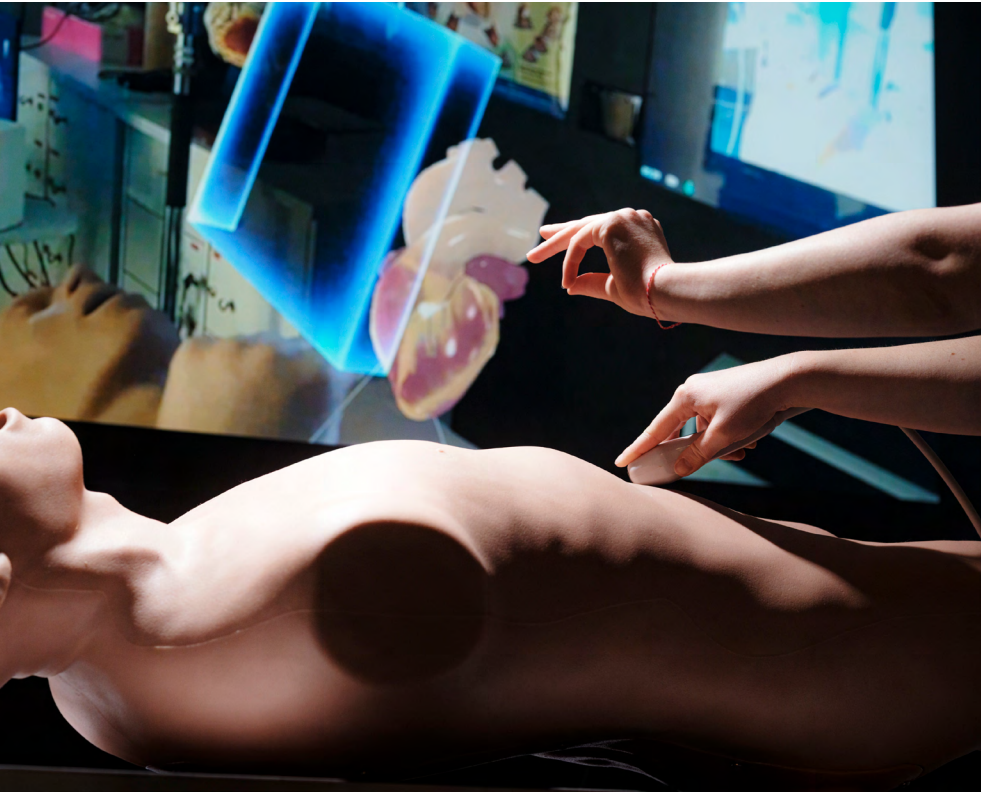
